**GOLD COAST GUNSLINGERS COWBOY ACTION SHOOTING CLUB, INC.  
GENERAL RELEASE FROM LIABILITY  
COWBOY ACTION SHOOTING AND RELATED ACTIVITIES**

**Gold Coast Gunslingers Cowboy Action Shooting Club, Inc.** (hereinafter "GCGS" or, in part, "Releasees") is a Florida non profit organization which sponsors, organizes and/or presents shooting sports and other social events.

Since the use of firearms is an inherently dangerous activity, GCGS requires all shooters and observers to assume all risk by signing this Release which is effective as of the date below and effective until revoked in writing, replaced or deemed ineffective by law.

I, \_\_\_\_\_ (print name), have voluntarily elected to be a shooter, observer, merchant or other participant in a shooting or social event.

**I RECOGNIZE AND ACKNOWLEDGE THAT SHOOTING SPORTS INVOLVE POTENTIALLY AND/OR INHERENTLY DANGEROUS ACTIVITIES AND I DO VOLUNTARILY, AND WITH FULL KNOWLEDGE AND UNDERSTANDING, ELECT TO PARTICIPATE IN AND/OR OBSERVE THESE GCGS EVENTS AND ASSUME ALL LIABILITY AND RISK ASSOCIATED WITH PARTICIPATING IN ALL GCGS/RELEASEES' EVENTS** and/or related activities including, but not limited to, children's games, entertainment, food service, and merchandise vendors.

AS LAWFUL CONSIDERATION of being permitted to enter upon the premises upon which this and future, events are conducted and of being permitted to participate in or observe activities or otherwise use the facilities, I, the undersigned, for my heirs, distributees, legal representatives, next of kin, and assigns agree to the provisions set forth and specifically state the following:

**I. RELEASE. By signing hereunder, I hereby unconditionally release, waive, discharge Releasees from all liability and covenant not to sue, make a claim against the property of or otherwise prosecute Gold Coast Gunslingers Cowboy Action Shooting Club, Inc., any of its affiliate organizations, its officers, directors, shareholders, agents, members and/or employees, or the County of Broward, the State of Florida, and/or any of its employees (for all purposes collectively referred to herein as "RELEASEES"), for liability on account of damage of my property or injury to me, whether caused from the passive or active negligence, recklessness or accidental action of RELEASEES while I, the undersigned, am participating in or observing the sporting or related activities being presented by RELEASEES.**

**II. WAIVER and INDEMNITY AGREEMENT. I HEREBY AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASEES and each of them INDIVIDUALLY FROM ANY AND ALL DIRECT OR INDIRECT LOSS, LIABILITY, DAMAGE OR COST WHICH RELEASEES may incur due to my and/or my guests' participation in and/or presence, or any act while participating in or observing the sporting or related activities presented by RELEASEES, whether caused by my or any of my guests' passive or active negligence, reckless or accidental act.**

**I AGREE TO COMPENSATE OR REIMBURSE RELEASEES FOR ANY DIRECT OR INCIDENTAL COSTS, EXPENSES, OR DAMAGES, INCLUDING ATTORNEY FEES, RESULTING FROM ANY CLAIMS BROUGHT AGAINST RELEASEES FOR PROPERTY DAMAGE, PERSONAL INJURY, OR DEATH, THAT ARISE AS A RESULT OF ANY PASSIVE OR ACTIVE NEGLIGENCE, RECKLESSNESS, ACCIDENT OR OTHER ACT BY ME AND/OR MY GUESTS WHILE PARTICIPATING IN OR OBSERVING THE SHOOTING AND/OR RELATED ACTIVITIES CONDUCTED BY RELEASEES.**

Notwithstanding anything to the contrary herein, nothing contained in this Agreement shall release any party from an intentional or willful act on its part which directly causes damage, injury, or death to the Undersigned or RELEASEES, except as required or allowed by law to prevent injury or death to others.

III. I expressly agree that the foregoing Release, Waiver and Indemnity Agreement is intended to be a broad and inclusive release, waiver and indemnification as is permitted by the laws of the State of Florida. Any and all legal actions shall be brought only in Broward County, Florida, regardless of any jurisdictional, diversity or venue matters allowed by law.

IV. I warrant that the following statements are true and correct and understand RELEASEES have relied on them in entering into this Agreement and are permitting me to participate in and/or observe the sporting and other activities being conducted by them:

A. No oral presentation, statements, or inducements apart from the foregoing written agreement have been made.

B. I am aware that participating in or the observation of the sport of cowboy action shooting with loaded firearms, equestrian events, and related activities is an inherently dangerous and hazardous activity. Being fully aware of the risks and hazards inherently therein, I voluntarily participate in or observe these activities with the knowledge and appreciation of the danger involved and agree to accept any and all risk of property damage, personal injury or death. I acknowledge the risks and hazards being assumed may increase during my participating in or observing the activities being conducted by RELEASEES.

C. I give consent to whatever medical care might be provided or available on the premises.

D. I further agree to conform and comply with all of the rules and regulations promulgated at the event(s) by Releasees including those rules established by the Single Action Shooting Society, GCGS, governmental authorities whether referenced, distributed in writing, posted, or verbalized.

Should any provision of this Agreement be held invalid, then any invalid section shall be severed but all remaining provisions hereof shall remain in full force and effect.
